Debbie,

I'm probably going to send you a few documents after the October 7 and November 4 meetings, although I realize November 4 is the deadline for submitting documents. I have collected so many things over the years that I forget I have them until I hear someone at the hearings talking about them.

I wrote that federal law suit that Ladd Huffman filed pro se against the FDA. Ladd just signed the papers after I wrote them. We moved to voluntarily dismiss the case when the FDA showed us that Ladd's doctor had failed to fill out the application properly and the federal program was closed before his doctor could get the paperwork completed. When we filed it, we thought Ladd and Barbara Douglass were similarly situated, and then the FDA showed us they were not. I figured it was too complicated for me to continue writing legal documents for Ladd at that point and we dropped the case. At that same time, a lawyer named Larry Hirsch filed a class action law suit on behalf of dozens of patients like Ladd in federal court in Pennsylvania, which is another reason I figured it was time for me to back out of writing the legal documents. That case is *Kuromiya v. United States*, 37 F. Supp. 2d 717 (E.D. Pa., March 10, 1999), and *Kuromiya v. United States*, 78 F. Supp. 2d 367 (E.D. Pa., December 1, 1999). Mary Lynn Mathre (co-founder of Patients Out of Time) tells me that she had just received the affidavits filed by those patients in that case (*Kuromiya*) and she will be submitting them to you as a package from that period of our history. I believe Larry Hirsch is currently serving on the Board of Directors or Board of Advisors for Patients Out of Time. Please add this short explanation to the administrative record to tie these pieces together.
